



Salén family increases in GarpcO AB

GarpcO AB is an investment company that owns and manages small and medium-sized industrial companies that are or may become an industry leader within its niche. "It's GarpcOs focus on small and medium-sized companies and its stable financial development that enticed me to invest in GarpcO just over a year ago," says Patrik Salén and continues, "Now when there is an opportunity to increase ownership in GarpcO, via my investment company Jippa Investment AB, I seize it".

GarpcOs B-shares are traded on the Alternative Stock market monthly. On this occasion, there was a sale of both A- and B-shares outside regular trading. The seller was the Garpheden family, where Leif Garpheden, soon to turn 64, now makes his exit.

"After living with GarpcO for so many years, it feels good to hand over to a new, confident owner" says Leif Garpheden. The family has already incorporated its next generation, there the daughters, Malin and Linda Garpheden, are included. They retain a total of 50 000 B-shares, representing 5.5% of the total shares of the company after the sale.

The new owners are Staffan and Eric Salén via Westindia AB and Ingrid Salén via Rentability Sweden AB. "We believe in the business idea and GarpcO will be a very exciting company to follow" says Ingrid Salén. This grouping will hold 10.7% of the total shares of the company, with 18.8% of the voting rights.
